1. To receive, consider and adopt the Audited Standalone Financial Statements of the Company for the Financial Year ended 31ST March, 2026, together with the Reports of the Board of Directors and the Auditors thereon.
2. To appoint a Director in place of Mr. Naresh Sitaram Saboo (DIN: 00223350), liable to retire by rotation in terms of section 152(6) of the Companies Act, 2013 and being eligible, seeks re-appointment.

To consider and if thought fit, to pass the following Resolution, with or without modification, as an **Ordinary Resolution**:

“RESOLVED THAT pursuant to the provisions of section 152 and other applicable provisions and the Rules framed thereunder, if any, of the Companies Act, 2013 (including any statutory modification(s) or re-enactment(s) thereof, for the time being in force), Mr. Naresh Sitaram Saboo (DIN: 00223350), who retires by rotation, and being eligible, seeks re-appointment, be and is hereby re-appointed as a Director, liable to retire by rotation.”

3. To Adopt new set of Memorandum of Association of the Company as per the Companies Act, 2013:

To consider, and if thought fit, to pass, with or without modification(s), the following resolution as a **Special Resolution**:

“RESOLVED THAT pursuant to the provisions of Section 4 and 13 and all other applicable provisions, if any, of the Companies Act, 2013 (the “Act”) read with the Companies (Incorporation) Rules, 2014 (including any statutory modification(s) or re-enactment thereof, for the time being in force), relevant regulations of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, if any, and subject to such other necessary statutory consent, approvals, permissions and modifications, if any, required, consent of the members of the Company be and is hereby accorded to alter by way of modification, deletion and subsume, as the case may be, the existing Memorandum of Association (“MOA”) of the Company in terms of **Table-A Schedule I** of the Act, as per the following details and adoption thereof:

- a) The title of the Clause III (A) be and is hereby amended from ***“The Main objects of the Company to be pursued by the Company on its incorporation are”*** to ***“The objects to be pursued by the Company on its incorporation are”*** with no changes in the existing sub-clauses numbered 1.
- b) The title of the Clause III (B) be and is hereby amended ***“Objects Incidental or Ancillary to the attainment of Main Objects of the Company are”*** to ***“Matters which are necessary for furtherance of the objects specified in Clause III (A) are”***.
- c) The existing sub clauses numbered **4, 7, 10, 11, 12, 18, & 20 under the title Clause III(B)** have been substituted with the following sub clauses:

- To enter into arrangements with any government or authorities municipal, local or any persons or company in India or abroad that may seem conducive to the objects of the company or any of them and to apply for, secure, acquire, obtain from such government, authorities, persons or company any right, privileges, powers, authority, charters, contracts, licenses, concessions, grants, decrees, rights which the Company may think desirable.
- To promote or join in the promotion of any company or companies including subsidiary companies (wholly owned or partly owned) for the purpose of acquiring all or any of the properties, rights and liabilities of the company or for any other purposes which may seem directly or indirectly calculated to benefit the Company and to underwrite shares and securities therein.
- To advance money not immediately required by the Company or give credit to such persons, firms or companies and on such terms with or without security as may seem expedient and in particular to customers of and such others having dealings with the Company and to give guarantees or securities of any such persons, firms, companies as may appear proper or reasonable provided that the Company shall not carry on the business of banking, within the meaning of Banking Regulation Act, 1949.
- Subject to the provisions of the Companies Act, 2013 including the rules and regulations made therein and the directions issued by Reserve Bank of India to borrow, raise or secure the payment of money or to receive money as loan, at interest for any of the objects of the company and at such time or times as may be expedient, by promissory notes, bills of exchange, hundis, bills of lading, warrants or such other negotiable instruments of all types or by taking credit in or opening current accounts or over-draft accounts with any person, firm, bank or company and whether with or without any security or by such other means, as may deem expedient and in particular by the issue of debentures or debenture stock, perpetual or otherwise and in security for any such money so borrowed, raised or received and of any such debentures or debenture stock so issued, to mortgage, pledge or charge the whole or any part of the property and assets of the Company both present and future, including its uncalled capital, by special assignment or otherwise or to transfer or convey the same absolutely or in trust and to give the lenders power of sale and other powers as may seem expedient and to purchase, redeem or pay off such securities provided that the Company shall not carry on the business of banking within the meaning of the Banking Regulation Act, 1949.
- To make, draw, accept, endorse, discount, execute, negotiate, assign, and issue cheques, promissory notes, drafts, hundis, bonds, railway receipts, bills of exchange, bills of lading, warrants, debentures, and other negotiable or transferable instrument subject to the directions issued by Reserve Bank of India.
- To pay all costs, charges and expenses of and incidental to the promotion, formation, registration and establishment of the Company and charges in connection therewith and/or make donations (by cash or other assets) to remunerate by allotment of fully or partly paid shares or by a call or option on shares, debentures, debenture stocks or securities of this or any other company or in any other manner, whether out of the Company's capital or profits to any person, firm, company assisting to place or guaranteeing the subscription of other security of the Company in or about the formation or promotion of the Company or for any other reason which the company may think fit subject to the provisions of the Companies Act, 2013.

- Subject to provisions of the Companies Act, 2013, to place, reserve, distribute, as dividend or bonus or to apply as the Company may from time to time determine any moneys received in payment of dividend or money arising from the sale of forfeited shares or any money received by way of premium on shares or debentures issued at a premium by the Company.
- d) The following new sub clauses numbered 21 and 22, have been inserted under the title Clause III(B) after existing sub clause no. 20:
- To donate, gift, contribute, subscribe, promote, support or aid or assist or guarantee money to charitable, benevolent, religious, scientific, national, public or to other institutions, funds or objects, or for any public, general or other objects and to accept gifts, bequests devices and donations from any firm, company or persons as may be thought appropriate or conducive to the interest of the Company.
 - To acquire or amalgamate, absorb or merge with any other company or companies or to form, promote subsidiaries having objects altogether or in part similar to those of this company.
- e) The existing Clause III(C) i.e. ***“Other Objects”*** containing sub clause numbered **21**, have been deleted in full.
- f) The existing Clause IV i.e. ***“The Liability of the members is limited”*** have been deleted and replaced by new Clause IV i.e. ***“The liability of the member(s) is limited and this liability is limited to the amount unpaid, if any, on the shares held by them”***.
- g) The existing Clause V have been deleted and replaced by new Clause V i.e. ***“The Authorised Share Capital of the Company is Rs. 3,50,00,000/- (Rupees Three Crore Fifty Lakh Only) divided into 35,00,000 (Thirty-Five Lakh) Equity Shares of face value of Rs. 10/- (Rupees Ten) each.”***

RESOLVED FURTHER THAT the words **“The Companies Act, 1956”** have been replaced with the words **“The Companies Act, 2013”** whenever appears in the existing Memorandum of Association of the Company.

RESOLVED FURTHER THAT any one of the Directors of the Company and Company Secretary be and are hereby severally authorized to do all the things and deeds as may be necessary including to file requisite forms with the Ministry of Corporate Affairs / Registrar of Companies, Gujarat, for and on behalf of the Company.”

NOTES:

1. A member entitled to attend and vote at the Annual General Meeting is entitled to appoint a proxy to attend and vote on his/her behalf. The proxy need not be a member of the company. A blank form of proxy is enclosed herewith and, if intended to be used, it should be returned duly completed at the registered office of the company not less than Forty-Eight hours before the scheduled time of the commencement of Annual General Meeting. In case of joint holders attending the meeting, the member whose name appears as the first holder in the order of names as per the register of members of the Company will be entitled to vote.
2. A person can act as proxy on behalf of members not exceeding fifty in number and holding in the aggregate not more than 10% of the total share capital of the company carrying voting rights. However, a member holding more than 10% of the total share capital of the company carrying voting rights may appoint a single person as proxy and such person shall not act as proxy for any other person or shareholder.
3. Corporate members intending to authorize their representatives to participate and vote at the Meeting are requested to send a certified copy of the Board Resolution/authorization Letter authorizing their representative. The shareholder needs to furnish the printed attendance slip along with a valid identity proof such as the PAN Card, Passport, Aadhaar Card or Driving License. Members holding equity shares in electronic form and proxies thereof are requested to bring their DP Id and client id for identification.
4. Members/Proxies/Authorized Representatives are requested to bring to the AGM, the enclosed Attendance Slip sent along with the Annual Report duly completed and signed mentioning therein details of their DP ID and Client ID/Folio Number. Duplicate Attendance Slip and/or Copies of the Annual report shall not be issued/ available at the venue of the meeting.
5. An Explanatory Statement pursuant to Section 102 of the Companies Act, 2013 which sets out details relating to special business to be transacted at the AGM is annexed hereto.
6. Details as required under Regulation 36(3) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations") and in terms of Secretarial Standard - 2 in respect of the Director seeking re-appointment at the 34th AGM are annexed hereto as **Annexure-I** to the Notice which forms part of the Explanatory Statement. The Company has received relevant disclosure/consent from the Director seeking re-appointment.
7. The Register of Members and share Transfer Book shall remain closed from **Tuesday, September 15, 2026 to Monday, September 21, 2026 (Both Days Inclusive)** for purpose of 34th AGM of the company.
8. Cut-off Date: The Company has fixed **Monday, September 14, 2026** as the Cut-off Date for remote e-voting. The remote e-voting/voting rights of the shareholders/beneficial owners shall be reckoned on the Equity Shares held by them as at close of business hours on the Cut-off Date i.e. Monday, September 14, 2026 only. A person who is not a Member as on the Cut-off Date should treat this Notice for information purposes only.
9. The voting rights of the Members shall be in proportion to the paid-up value of their shares in the equity capital of the Company as on the Cut- off Date, being Monday, September 14, 2026.

10. The Board of Directors has appointed **M/s. Dhirren R. Dave & Co.** Company Secretaries, Surat, as Scrutinizer to scrutinize the remote e-voting process and voting through electronic voting system at the AGM in a fair and transparent manner.
11. The Scrutinizer shall, after conclusion of voting at the AGM, first download the votes cast at the meeting and thereafter unblock the votes cast through remote and e-voting in the presence of at least 2 (two) witnesses not in the employment of the Company and shall within two working days of conclusion of the AGM, submit a Consolidated Scrutinizer's Report of the total votes cast in favour or against, if any, to the Chairman or any KMPs of the Company who shall countersign the same and declare the results of voting forthwith.
12. The resolutions will be deemed to be passed on the AGM date subject to receipt of the requisite number of votes in favour of the resolutions. - III. The members attending the Meeting who have not cast their vote by remote e-voting shall be able to vote at the Meeting through 'polling paper'. The members who have

cast their vote by remote e-voting may also attend the Meeting but shall not be entitled to cast their vote again.

- IV. Pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended) and Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015 (as amended), and the relevant Circulars issued by the Ministry of Corporate Affairs, the Company is providing facility of remote e-Voting to its Members in respect of the business to be transacted at the AGM. The voting right of shareholders shall be in proportion to their share in the paid-up equity share capital of the Company as on the cut-off date, being Monday, September 14, 2026.

How do I vote electronically using NSDL e-Voting system?

The way to vote electronically on NSDL e-Voting system consists of “Two Steps” which are mentioned below:

Step 1: Access to NSDL e-Voting system

A) Login method for e-Voting for Individual shareholders holding securities in Demat mode

In terms of SEBI circular dated December 09, 2020 on e-Voting facility provided by Listed Companies, Individual shareholders holding securities in Demat mode are allowed to vote through their Demat account maintained with Depositories and Depository Participants. After successful authentication, you will be able to see e-Voting services under Value added services. Click on “Access to e-Voting” under e-Voting services and you will be able to see e-Voting page. 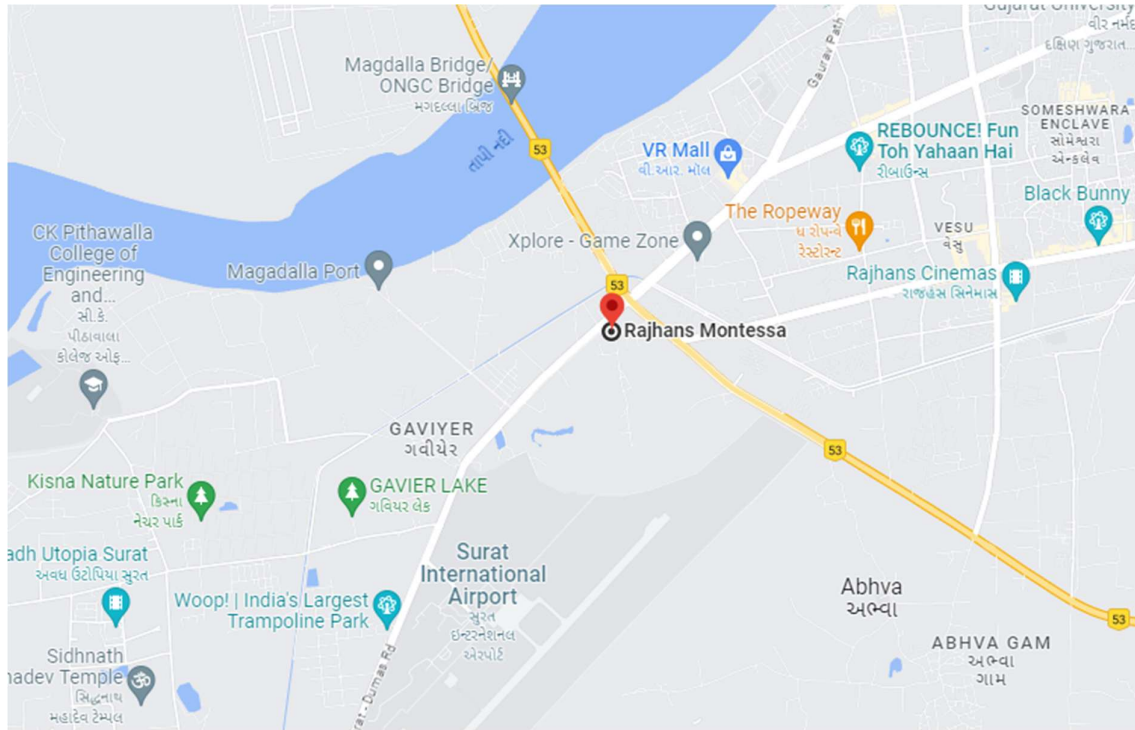

However, the NBFC Registration of the Company has been cancelled by Reserve Bank of India (RBI) vide its order dated July 18, 2018 received by the Company on July 19, 2018 due to non-attainment of Net Operating Funds requirement as per RBI Act 1934 and in future the company wishes to apply for fresh certificate of registration after attainment of Net Operating Fund as per RBI Act, 1934. The Company has surrendered its Certificate of registration on January 18, 2019.

The Major income of the Company is from Interest on loan and advance given to others and Dividend received from the Investments made by the Company, which may be receivable on Investment held by it in the Group or associate Company. Any adverse impact on the Business of the Group Companies will have a bearing on the performance of your Company.

Notes Forming Part of Financial Statements for the year ended 31st March, 2026

1. REPORTING ENTITY:

Mask Investments Limited ('the company') is a public limited company listed on National Stock Exchange (NSE) and incorporated under the provisions of the Company Law. The company is having its registered office at Office No. 908, 9th Floor, Rajhans Montessa, Dumas Road, Magdalla, Surat - 395007. The company is primarily engaged in investments in shares of its related parties' companies and giving loans.

2. BASIS OF PREPARATION:

Statement of Compliance:

The financial statements (on standalone basis) of the Company have been prepared in accordance with Indian Accounting Standards (Ind AS) notified under Companies (Indian Accounting Standards) Rules, 2015 amended from time to time, notified under section 133 of the Companies Act, 2013 ('the Act'). The financial statements are approved for issue by the Company's Board of Directors on 30.05.2026

Functional and presentation of currency:

The financial statements are prepared in Indian Rupees which is also the Company's functional currency.

Basis of measurement:

The financial statements have been prepared on a historical cost basis except for following items which are measured on alternative basis on each reporting date.

Use of significant accounting estimates, judgements and assumptions:

The preparation of financial statements requires the management to make estimates and assumptions considered in reported amounts of assets and liabilities (including contingent liabilities) and the reported income and expenses during the year. The management believes that estimates used in preparation of financial statements are prudent and reasonable. Future results could differ due to these estimates and the difference between actual results and the estimates are recognized in the periods in which these gets materialized.

3. MATERIAL ACCOUNTING POLICIES:

3.1 Presentation and disclosure of financial statements:

All assets and liabilities have been classified as current and non-current as per Company's normal operating cycle and other criteria set out in the division II of Schedule III of the Companies Act, 2013, for a Company whose financial statements are made in compliance with the Companies (India Accounting Standards) Rules, 2015. Deferred tax liabilities are classified as non-current liabilities. Based on the nature of business and their realization in cash and cash equivalents, 12 months has been considered by the Company for the purpose of current / non-current classification of assets and liabilities.

3.2 **Financial instruments:**

All financial instruments are recognized initially at cost. Transaction costs that are attributable to the acquisition of a financial asset (other than financial assets recorded at fair value through OCI), are included in the value of the financial asset. Purchases or sales of financial assets that require delivery of assets within a time frame established by regulation or convention in the market place ("regular way trade") are recognized on the trade date. While, Loans and borrowings and payables are recognized net of directly attributable transaction costs.

Subsequent Measurement:

The classification of financial instruments depends upon the objective of the business model for which the financial instrument is held. Management determines the classification of financial instruments at the time of initial recognition.

a) Non-Derivative Financial Assets:

(i) Financial Assets at Amortized Cost

A financial asset is measured at amortized cost if both of the following conditions are met:

- (a) the financial asset is held within a business model whose objective is to hold financial assets in order to collect contractual cash flows; and
- (b) the contractual terms of the financial asset give rise, on specified dates, to cash flows that are solely payments of principal and interest ("SPPI") on the principal amount outstanding.

They are presented as current assets, except for those maturing later than twelve months after the reporting date, which are presented as non-current assets. Financial assets are initially measured at fair value plus transaction costs and are subsequently carried at amortized cost using the effective interest method, less any impairment loss.

Trade receivables, security deposits, cash and cash equivalents, employee and other advances, and eligible current and non-current assets are measured at amortized cost.

(ii) Equity Instruments at FVTOCI

All equity instruments are measured at fair value. Equity instruments held for trading is classified as Fair Value through Profit and Loss ("FVTPL"). For all other equity instruments, the Company may make an irrevocable election to present subsequent changes in fair value in Other Comprehensive Income ("OCI"). Such election is made by the Company on an instrument-by-instrument basis.

If the company decides to classify an equity instrument as FVTOCI, then all fair value changes on the instrument, excluding dividends, are recognized in OCI and are not subsequently reclassified to the Statement of Profit and Loss.

b) Non-Derivative Financial Liabilities

(i) Financial Liabilities at Amortized Cost

Financial liabilities measured at amortized cost, comprising borrowings, trade payables and other payables, are initially recognized at fair value and subsequently carried at amortized cost using the effective interest rate method.

3.3 Revenue Recognition

Revenue is recognized to the extent that it is probable that the economic benefits will flow to the Company and the revenue can be reliably measured.

Interest income in respect of debt instruments and deposits that are measured at cost or at fair value through Other Comprehensive Income is recognized using the Effective Interest Rate ("EIR") method. EIR is the rate that exactly discounts the estimated future cash payments or receipts over the expected life of the financial instrument, or a shorter period, where appropriate, to the gross carrying amount of the financial asset or to the amortized cost of a financial liability. Interest income is included under Revenue from Operations in the Statement of Profit and Loss.

3.4 Employee Benefits

- (a) All short-term employee benefits are accounted for on the basis of services rendered by the employees of the Company.
- (b) The Company contributes towards Provident Fund, which is a defined contribution scheme. The liability in respect thereof is determined on the basis of the contribution required to be made in accordance with the applicable statutes and rules.
- (c) No provision has been made for long-term employee benefits such as gratuity and leave encashment, as the same are recognized as and when they become due for payment.

3.5 Borrowing Cost

Borrowing costs comprise interest and other costs incurred in connection with the borrowing of funds. Borrowing costs that are attributable to the acquisition, construction or production of qualifying assets are capitalized as part of the cost of such assets. A qualifying asset is one that necessarily takes a substantial period of time to get ready for its intended use. All other borrowing costs are charged to the Statement of Profit and Loss.

3.6 Taxes on Income

Tax expense for the year comprises current tax, deferred tax charge or credit and adjustments relating to taxes for earlier years. In respect of amounts adjusted outside profit or loss, i.e., in Other Comprehensive Income or equity, the corresponding tax effect, if any, is also adjusted outside profit or loss.

Provision for current tax is made in accordance with the provisions of the Income Tax Act, 1961.

Deferred tax is provided using the liability method on temporary differences between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes at the reporting date. Deferred tax liabilities are recognized for all taxable temporary differences, while deferred tax assets are recognized for all deductible temporary differences, carry-forward tax losses and allowances to the extent that it is probable that future taxable profits will be available against which such deductible temporary differences, carry-forward tax losses and allowances can be utilized. Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the year when the asset is realised or the liability is settled, based on tax rates and tax laws that have been enacted or substantively enacted at the reporting date. Deferred tax assets and deferred tax liabilities are offset when a legally enforceable right exists to set off

current tax assets against current tax liabilities and the deferred taxes relate to the same taxation authority.

3.7 Provisions and Contingent Liabilities

A provision is recognized when the Company has a present obligation, whether legal or constructive, as a result of a past event, and it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and a reliable estimate can be made of the amount of the obligation.

A disclosure for a contingent liability is made when there is a possible obligation or a present obligation that may, but probably will not, require an outflow of resources embodying economic benefits.
